5. AWARD ACTIVITIES. AN AWARD CEREMONY AND ASSOCIATED EVENTS WILL TAKE PLACE IN WASHINGTON, DC, ON 29-30 MAY 2014. ADDITIONAL INFORMATION CONCERNING EVENTS, LODGING AND TDY REQUIREMENTS WILL BE SENT SEPARATELY TO AWARD RECIPIENTS.

6. FUNDING. IN ACCORDANCE WITH PARA 11A OF AR 600-89, ALL COMMANDS WILL PROVIDE FUNDING FOR TRAVEL, LODGING AND PER DIEM FOR THEIR RESPECTIVE RECIPIENTS TO ATTEND THE AWARD CEREMONY AND ASSOCIATED ACTIVITIES IN WASHINGTON, DC. FUNDING AUTHORITY MAY BE DELEGATED TO THE INSTALLATION LEVEL BY ARMY COMMANDS AND TO THE STATE OR REGION FOR THE ARMY NATIONAL GUARD AND THE U.S. ARMY RESERVE. ALL COMMANDS ARE AUTHORIZED AND STRONGLY ENCOURAGED TO ISSUE INVITATIONAL TRAVEL ORDERS FOR RECIPIENTS' SPOUSES OR ONE IMMEDIATE FAMILY MEMBER TO ATTEND THE EVENTS WITH THE RECIPIENT.
