### **Points of Contact**

### **Description**

The SF 1174 (Claim for Unpaid Compensation of Deceased Member of the Uniformed Services) is completed by the surviving beneficiary(ies). This form is completed in order for the surviving beneficiary(ies) to receive unpaid compensation (i.e., Savings and Deposit Program (SPD), Unpaid Pay and Allowances (UPPA), accrued leave, and unpaid reenlistment bonuses) due to the deceased Soldier. The surviving beneficiary is determined by reviewing the deceased Soldier's DD Form 93 (Record of Emergency Data) block 12A; a separate SF 1174 needs to be completed for each beneficiary listed.



2	Complete SF 1174	Designated beneficiary(ies) completes SF 1174 (Claim for Unpaid Compensation of Deceased Member of the Uniformed Services) with assistance from CAO. After completing SF 1174, two people who know the beneficiary must witness them signing the form.		SF 1174		
3	Send SF 1174	Once complete, CAO sends SF 1174 (Claim for Unpaid Compensation of Deceased Member of the Uniformed Services) to Casualty Assistance Center (CAC) via email or fax.		SF 1174
