### **Point of Contact**

**Division:** Soldier Family Support and Services Division (ARNG-HRF)

### **Description**

The next of kin (NOK) may be reimbursed for funeral expense to include removal of remains, preparation of remains and casket, etc. Some expenses will not be reimbursed and they include: certified death certificates, food or catering, cars for other than the Soldier's parents, spouse, and children or stepchildren, perpetual care, and services or merchandise not directly related to the interment.



1	Identify reimbursement for funeral expense?	Casualty Assistance Officer (CAO) discusses reimbursement for funeral expenses with next of kin (NOK).				
2	Complete DD Form 1375	NOK completes DD Form 1375 (Request for Payment of Funeral and/or Interment Expenses) with assistance from CAO. This should be completed as soon as possible after the funeral. NOK is encouraged to have the reimbursement paid directly to the funeral home.	AR 600-8-1, Appendix O	DD Form 1375		
3	Send DD Form 1375	CAO sends DD Form 1375 (Request for Payment of Funeral and/or Interment Expenses) to Casualty Assistance Center (CAC). The method of delivery depends on the location of the CAC (e.g. hand delivery, fax, or email).		DD Form 1375		
4	Receive DD Form 1375	CAC receives DD Form 1375 (Request for Payment of Funeral and/or Interment Expenses) from CAO. The method of delivery depends on the location of the CAC e.g. hand delivery, fax, or email).		DD Form 1375
