Travel days are 20 and 25 January (see course schedule prior to scheduling return flights). Registration for the course will begin on 6 November 2007.

This course is designed for new state GI Bill managers. It provides in-depth training created to develop the knowledge, administrative skills and managerial abilities to effectively and efficiently manage the State GI Bill office. This course will cover eligibility criteria, benefits, and processing procedures for all GI Bill Programs.

Registration for this course closes on 14 January 2008.
