MEMORANDUM FOR THE ADJUTANTS GENERAL OF ALL STATES, PUERTO RICO, THE VIRGIN ISLANDS, GUAM AND THE COMMANDING GENERAL, OF THE DISTRICT OF COLUMBIA

SUBJECT: (All States Log Number P01-0050) Utilization of Army Medical Department (AMEDD) Branch Immaterial (05A) Positions

1. References:

a. DA Pam 611-21, 31 March 1999, "Military Occupational Classification and Structure" and Notice(s) For Change (NOFC).

b. National Guard Regulation (AR) 600-100, 15 April 1994, "Commissioned Officers – Federal Recognition and Related Personnel Actions".

2. The purpose of this memorandum is to provide implementing guidance regarding fill of AMEDD Branch Immaterial (05A) positions.

3. The 05A positions may be filled by any AMEDD Officer. They are designed for personnel with a thorough working knowledge of the medical environment, and are typically senior and/or supervisory positions. The AMEDD officers include the following Branches: MC (60-62 Series Areas of Concentration (AOCs)), DE (63 Series AOCs), AN (66 Series AOCs), SP (65 Series AOCs), VC (64 Series AOCs and 75 Series Medical Functional Areas (MFAs)) and MS (67 Series AOCs and 70-73 Series MFAs).

4. Any officer with a primary AOC/MFA listed in item 3 above may be placed in an 05A duty position, consistent with any grade limitations set forth in any regulation or policy this includes all AMEDD AGR, Technician, and M-Day Officers. Non-AMEDD officers will not be assigned to 05A positions.

a. A Technician AMEDD Officer may hold a 05A Technician position, and either an M-Day position (as required to be a Technician) that is coded 05A or a position that is AOC/MFA specific to the individual's primary AOC/MFA (or an authorized substitution as published in enclosure 2 of the annual policy letter P01-0030 dated 17 April 2001 from the Office of the Chief Surgeon).

b. The AMEDD Branch Immaterial (05A) will not be awarded as a primary AOC. It is a duty position AOC only.
