Death Gratuity Process: Ensuring beneficiary(ies) receives death gratuity payment

Description

Death gratuity payment is intended to assist the beneficiary(ies) with immediate financial needs until long-term benefits commence. Death gratuity is paid in the amount of \$100,000. Effective July 1, 2008, a Soldier may designate on DD Form 93 (Record of Emergency) one or more beneficiary(ies) to receive all or a portion of the death gratuity payment. Death gratuity is paid to beneficiary(ies) of a: deceased active duty Soldier, Soldiers who die within 120 days of separation, or retirement from active duty if death is a result of service-connected injury or illness.


